

**CHALLENGE ADVENTURES WAIVER OF LIABILITY
(ADULTS, PARENT(S) OR GUARDIANS)**

The activities covered by this waiver include active outdoor activities such as hiking, backpacking, back country camping and interactions with trained pack llamas. Although Challenge Adventures takes reasonable steps to provide participants with appropriate equipment and skilled staff, there are certain risks that cannot be eliminated without destroying the character of the experience. Many activities take place in remote areas, many miles from roads or medical facilities, in all types of weather conditions. By signing this waiver, I acknowledge that my participation in outdoor experiential activities includes some risk of physical discomfort or injury. If there is an illness or injury, I understand that CHALLENGE ADVENTURES will make very effort to provide immediate care and seek medical attention for me, if needed. I understand that any such care and attention will be at my own expense. I further understand and agree that any type of injury, illness or malady is at my risk and not at the risk of CHALLENGE ADVENTURES, its employees, or its agents. Challenge Adventures is not liable for any injury caused by the participant's negligence.

I attest that I do not have any physical or medical condition that will endanger myself or others in the group.
